ORDER

Government have envisaged Kerala Solid Waste Management Project under Local Self Government Department with the assistance of World Bank to strengthen the institutional capacity of all Urban Local Bodies (ULBs) and to provide additional support in waste management, septage and sewage management and sanitation sector.

2. As per Government order read as 1st paper above, a State Project Management Unit (SPMU) has been constituted for implementing the project and as per Government Order read as 2nd paper above the Project Implementation Manual has been approved. The guidelines of Project Implementation Manual specifies the provision of a GIS based system to monitor the transportation of waste.

3. The Project envisages the use of advanced MIS together with GIS, GPS, Radio Frequency Identification (RFID) and General Packet Radio Services (GPRS) by ULBs which will enable generation and processing of data on daily basis for vehicle and equipment management, co-ordination of the waste value chain and timely corrective action.

4. As per letter read as 3rd paper above the Project Director, KSWMP reported that the services of a GIS Expert is felt essential for carrying out the activities in the State Project Management Unit. Project Director, KSWMP has requested to accord sanction for appointing a GIS Expert on contract basis on a consolidated payment of Rs.60,000/- (Rupees Sixty Thousand only) per month as detailed below.
