### ORDER

The Chief Engineer, KSRRDA has reported, as per letter read above, that total estimated amount for the balance work of two roads viz, Devarupara-Naliyani Road and Perngasserri-Cheppukulam Road of Package No. KR-03-27 Elamdesom Block, Idukki District under PMGSY-2008-09 - Phase VII, comes to ₹4,87,39,823/- as per DSR 2018. The CE has also reported that the estimates are prepared as per the site requirements and there is no duplication of items in the already executed work and in the newly proposed work. He has requested for Administrative Sanction of the balance work for aforesaid amount.

2.Government have examined the matter in detail. On revision of Schedule of Rates (SoR) for the subject work from DSR 2016 to DSR 2018, there is a cost enhancement of @12% only, which seems reasonable. Also, on a general Scrutiny of the estimates, it is found that the provisions in the estimate are justifiable on technical grounds. In the circumstances, Government are pleased to accord Administrative Sanction for the balance works of two roads viz, Devarupara-Naliyani

Road and Perngasserri-Cheppukulam Road of Package No. KR-03-27  
Elamdesom Block, Idukki District under PMGSY-2008-09 - Phase VII,  
for an amount of ₹4,87,39,823/- (Rupees Four crore Eighty seven lakh  
Thirty nine thousand Eight hundred and twenty three only).
