### **ORDER**

As per the letter read as 2nd paper above, the Mission Director, AMRUT has informed that the proposal of Thrissur Corporation for Administrative Sanction for 16 new works (SWD Sector: 7 works, Park Sector: 4 works, UT Sector: 2 works, WS Sector: 2 works & SEW Sector: 1 work) were placed in the 30th SHPSC for approval.

- 2. The SHPSC for AMRUT has decided to accord sanction to 16 new works of Thrissur Corporation subject to certain conditions.
- 3. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the 16 new works of Thrissur Corporation detailed below subject to the following conditions stipulated by the SHPSC for AMRUT:-
  - 1) The required amounts shall be met from the available savings in Storm Water Drainage, Park & Urban Transport Sectors and shortcomings, if any, shall be borne by the ULB.
  - 2) The works shall be completed by 31.03.2023.
  - 3) Any financial implication due to incompletion of works by 31.03.2023 shall be borne by the ULB.
