### ORDER

Silk Samagra is a Centrally Sponsored Scheme. The subsidy pattern under Silk Samagra-2 is 50% Central Share, 25% State Share and 25% Beneficiary Share. Now this Sericulture activities concentrated in three potential Districts viz. Idukki, Wayanad and Palakkad in Kerala State. An amount of ₹150 lakh (Central share ₹100 lakh & State share ₹50 lakh) is earmarked under the Head of Account '2515-00-102-28', for implementing the "Silk Samagra-2" Scheme, in the budget for the Financial Year 2022-23.

2.As per Minutes read as 1<sup>st</sup> paper above the Departmental Working Group dated 18.04.2022 approved the proposal for Administrative Sanction for an amount of ₹150 lakh earmarked in the State Budget under the H/A'2515-00-102-28' for implementing Silk Samagara-2 project, subject to the condition that Assistant Sericulture officer will be the implementing officer and the State level Additional Director will be

the Co-ordinating Officer. The component wise financial outlay of the Scheme during 2022-23 is detailed below.
