### ORDER

As per Government Order read as 1<sup>st</sup> paper above Extreme Poverty survey was conducted and the same was completed on 31<sup>st</sup> March, 2022. Guidelines for Micro Plans for Extreme Poverty have been issued vide Government Order read as 6<sup>th</sup> paper above for implementation. The families identified in the extreme poverty survey are to be uplifted within the timelines and through projects specified in the microplans.

To ensure that the intended outcomes are achieved in a timebound manner, it has been decided to constitute a Committee at the State level for helping persons out of extreme poverty. The committee will look at the challenges involved in ascertaining which families can be brought out of poverty in what time frame. The number of families to be so supported each year is to be projected based on the assessment of the data on the nature of extreme poverty. The State Level Committee is constituted with the following members for this purpose:

1. Vice Chairperson, State Planning Board

2. Chief Secretary
3. Additional Chief Secretary, Finance
4. Additional Chief Secretary, LSGD (convenor)

The Committee will submit its recommendations to Government within three weeks. The office of the Principal Director, LSGD will function as the Secretariat to the Committee.
