## 2 Judgment dated 18.01.2022 in WP(C) 29784/2017 ORDER

In compliance to the the Judgment in WP(C) 11306/11, Smt. Omana Kunju, daily waged sweeper has been regularized after creating a post of part time sweeper at Nellikuzhy Gramapanchayat from the date of the Government order read as 1<sup>st</sup> paper above. Smt. Omana Kunju filed WP(C) 29784/2017 before the Hon'ble High court demanding retrospective regularization with effect from 18.06.2001 as envisaged in GO(P) No. 501/2005/Fin dated 25.11.2005. In the judgement dated 18.01.2022 in WP(C) 29784/2017 ordered as follows:

- "............ having heard the learned Counsel on either side and being guided by the decision in O.P(KAT) No. 401 of 2020, the writ petition is disposed of, directing the first respondent to reconsider Ext.P10 order and take an appropriate decision with respect to the date of regularisation of petitioner's service. While taking the decision, specific reference shall be made to the judgment in O.P(KAT) No. 401 of 2020. The decision shall be taken within an outer limit of two months of receipt of a copy of this judgment and the monetary benefits consequent to such decision, disbursed to the petitioner within two months thereafter."
- 2. The Ext.P10 is the Order read as 1st paper, regularising the service of Smt. Omana Kunju as part time sweeper with effect from the date of order. The

Hon'ble High Court in OP(KAT) No. 401/2020 directed the Government to reconsider Order read as 1st paper.

- 3. Government have examined the matter in detail and are pleased to regularize the appointment of Smt. Omana Kunju as part time Sweeper at Nellikuzhy Gramapanchayat with effect from 09/02/2010, the stipulated date for regularisation of daily wage sweepers satisfying the regularisation norms laid down in G.O.(P) No. 501/2005/fin dated 25.11.2005.
- 4. The Judgement read as 1st paper above of the Hon'ble High Court is complied with.
