## **ORDER**

Shri.Reghuraman was promoted to the post of Joint Director as per the Government Order read as 1<sup>st</sup> paper above and the Officer joined duty on 30.01.2021. As per the letter read as 2<sup>nd</sup> paper above, the Director of Urban Affairs has recommended his application for declaration of probation in the cadre of Joint Director. The Director of Urban Affairs has certified that the work and conduct of the applicant are good. No disciplinary action or vigilance case was pending against the incumbent during the period of probation.

The probation period in the post of Joint Director is six months duty within a continuous service period of one year. Hence the period of probation in respect of Shri. Reghuraman, Joint Director is from 30.01.2021 to 29.07.2021. The Executive Director, State Poverty Eradication Mission has reported that he has availed 20 days Earned Leave (01.02.2021 to 20.02.2021) and 90 days Commuted Leave(from 21.02.2021 to 21.05.2021) during the period of probation. Hence his probation is extended up to 16.11.2021.
