**ORDER**

The Kerala Public Service Commission, as per the letter read above, has advised **Shri.Reshnu.R.S., Pournami, Nellikkakuzhi, Thiruvananthapuram, Kanjiramkulam-695524** for appointment to the post of Public Health Officer Gr III (Municipality /Corporation/Medical Officer(Modern Medicine)/Superintendent(Child Welfare Centre)/Lady Medical Officer on ₹45800-89000 (Revised) in Municipal Common Service.

2. In the circumstances, **Shri.Reshnu R.S., Pournami, Nellikkakuzhi, Thiruvananthapuram, Kanjiramkulam-695524** advised by Kerala Public Service Commission is provisionally appointed to the post of Public Health Officer Gr III(Municipality /Corporation/Medical Officer(Modern Medicine)/Superintendent(Child Welfare Centre)/Lady Medical Officer on ₹45800-89000 (Revised) in Municipal Common Service and are appointed as Health Officer Grade III/Lady Medical Officer/Medical officer (Allopathy) , Thiruvananthapuram Corporation in the existing vacancy.

3. The appointment of the candidate is subject to Rule 3(c) of the General Rules of Kerala State & Subordinate Service Rules, 1958.

4. The candidate shall report before the Secretary, Corporation of Thiruvananthapuram with relevant records in proof of age, qualification, Community Certificate etc. within 15 days from the date of receipt of the order and the Secretary of Thiruvananthapuram Corporation should verify the records before he is admitted to duty. The Secretary of Corporation should obtain a Medical Certificate from the candidate as prescribed in G.O.(P) No.20/2011/P&ARD dated 30.6.2011 before appointment. As ordered in G.O. (Ms) No.170/74/PD/Public Services (D) dated 18.07.1974, the appointing authority has to obtain the necessary details of the candidate duly filled up in the prescribed proforma and to make necessary arrangements for the verification of character and antecedents of the candidate. But before the character and antecedents of the candidate are verified, the appointing authority may appoint any candidate mentioned in the letter temporarily under clause (1) of sub rule (a) of Rule 9 of the General Rules as provided for in Rule 10(b) of those rules (vide G.O.(P) No.49/74/PD dated 05.03.1974). The signature of the candidate on the passport size photograph affixed to the Identification Certificate and the photograph should be verified by the Secretary of Corporation and the fact may be recorded on the Scanned Copy of Identification Certificate itself. The date of birth and qualifications of the candidate shall be verified before he is admitted to duty. In the case of candidate whose community is also noted, the same may be verified with prescribed community certificates. If there is any discrepancy, the candidate should not be allowed to join duty and the fact should be reported forthwith. After the candidate is allowed to join duty, the Scanned Copy of Identification Certificate verified and found acceptable may be kept pasted in his Service Book.

5. The Director of Urban Affairs shall also forward the proforma for verification of character and antecedents to Government in due course. The appointment shall be regularized only after obtaining a verification certificate from Kerala Public Service Commission. For this purpose, the Director of Urban Affairs shall forward an attested copy of the relevant pages of the Service Book of the incumbent to Government as ordered in G.O.(P) No. 20/2011/P&ARD dated 30.6.2011 along with the original One Time Verification Certificate

6. In the event of discharge from service for want of vacancies, the candidate may either re-register his/her name in the Office of the Public Service Commission/District Office of the Public Service Commission from where he was advised and get himself re-appointed on further advice by the Public Service Commission or he may wait for his turn for re-appointment to the post in the Department, in case he desires to continue as probationer in the posts from which he/she is discharged (vide Government Circular Memorandum No. 3737/Rules-1/90/P&ARD dated 29.3.1990 and G.O.(P) No.7/91/P&ARD dated 15.2.1991).
