ORDER

Sri.Hamza.V,P filed WP(C) No.2752/2021 before the Hon'ble High Court due to the non payment of amount for the renovation of Kottuvad Sivakshethram Puthiya Parambath Road work executed by him.

- 2) The Hon'ble High Court in its judgment dated 01/11/2022 disposed the WP(C) No.2752/2021 with the following directions:-
- (i) The Chief Enginer, LSGD shall forward the proposal to the Government for allotment of sufficient funds for the subject work within three weeks.
- (ii) Within three weeks of receipt of the proposal, the competent officer in the Government shall take necessary action for sanctioning and disbursing the amount to the 9th respondent.
 - (iii) On receipt of the amount, the 9th respondent shall honour the

bill submitted by the petitioner within two weeks.

- 3) In his letter read above, the Chief Engineer, Local Self Government Department has submitted proposal for the allotment of funds for the disbursal to the petitioner.
- 4) Government have examined the matter in detail on the basis of the proposal of the Chief Engineer and are pleased to accord sanction to the Chief Engineer, Local Self Government Department to meet the expenditure for the work from the h/a 4515-00-800-92-NV Works included in Appendix II to the detailed budget estimate.
- 5) The direction contained in the judgment read above is thus complied with.
