ORDER

Government of India redesigned and expanded the 'Scheme for Special Assistance to States for Capital Expenditure' and launched in the name 'Scheme for Special Assistance to States for Capital Investment 2022-23' for providing financial assistance to the State Governments in the form of 50-year interest free loan for capital investment projects. As per the sanction order read as 1st paper above, an amount of ₹44.45 crore was released to the State of Kerala under Part III of the above Scheme for supplemental funding for PMGSY including support from State Share. The amount released shall be utilized by 31.03.2023.

- 2. The Member Secretary, KSRRDA has requested to transfer the aforesaid amount for supplemental funding for PMGSY including support from State Share in priority districts viz, Malappuram, Palakkad and Wayanad, to the Single Nodal Account of PMGSY.
- 3. In the above circumstances, Government are pleased to accord sanction to release an amount of ₹44,45,00,000/- (Rupees Forty four crore Forty five lakh only) released by GoI under 'Scheme for special assistance to the State for capital investment for 2022-23', by debiting

the H/A 2515-00-800-74(02). The amount will be transfer credited to the Single Nodal Account of PMGSY (Account No.10347397270 maintained in SBI, Nanthencode Branch by Member Secretary, KSRRDA). The amount released shall be utilized by 31.03.2023.

4. The conditions stipulated in the sanction order read as 1st paper above shall strictly be complied with.
