- 2) Letter No. SMMU/166/2022/UP2 dated 21.1.2022 from the Mission Director, Amrut.

ORDER

The Mission Director, Amrut, as per the letter read as 1st paper above, has informed that the proposal of Kozhikkode Corporation for issuance of Administrative Sanction for the new Storm Water Drainage Sector work, "Mavoor Road Drain" was placed in the 31st SHPSC for approval and the Committee decided to accord Administrative Sanction of Rs.3.63 Cr. for the new Storm Water Drainage work, "Mavoor Road Drain" subject to the following conditions:

- 1) The amount required for the work shall be met from the available savings in Storm Water Drainage Sector and shortcomings if any shall be borne by the ULB.
- 2) The work shall be completed by 31.03.2023.
- 3) Any financial implications due to non-completion of the work by 31.03.2023 shall be borne by the ULB.

2) The Mission Director, Amrut, has also informed that the Council of Kozhikkode Corporation has decided to execute the work through the PWD as a deposit work. Hence, the Mission Director, Amrut has requested that the necessary Government Order may be issued at the

earliest based on the decision of the 31st SHPSC, including permission for the ULB to execute the work through the PWD as deposit work.

3) Government have examined the matter in detail and are pleased to accord Administrative Sanction of Rs.3.63 Crores for New Storm Water Drainage Sector Work in Kozhikkode Corporation namely "Mavoor Road Drain" on conditions that the amount required for the work shall be met from the available savings in Storm Water Drainage Sector and shortcomings if any shall be borne by the ULB and the work shall be completed by 31.03.2023 and any financial implications due to non-completion of the work by 31.03.2023 shall be borne by the ULB. Permission is also granted for the ULB to execute the work through the PWD as deposit work.
