ORDER

As per G.O read as 1st paper above, administrative sanction was issued for various projects of AMRUT, including Septage Treatment plant at Chakkamkandam. The Mission Director, Amrut, as per the letter read as 3rd paper above, has informed that the proposal of cancellation of the project "Septage Treatment Plant at Chakkamkandam",retaining an amount of Rs.0.50 Cr. for the purchase of septage vehicles and reallocation of the balance amount to the Sewerage & Septage Sector proposals in other ULBs was placed in the 31st SHPSC for approval and the Committee decided to accord Sanction to cancel the work of Septage Treatment Plant at Chakkamkandam subject to the following conditions:

1)The amount of Rs.0.50 Cr. set aside in the DPR for the collection & conveyance of septage shall be utilized for the purchase of septage vehicles for the ULB.

- 2) The balance amount of Rs.4 Cr. shall be transferred to the new sewerage / septage proposals in other ULBs.
- 3) The expense incurred so far for the septage project shall be borne by the ULB.
- 2. The Mission Director, Amrut vide letter referred as 3rd paper above, requested that the necessary Government Order may be issued at the earliest by reducing the AS Amount of the work of "Septage Treatment Plant at Chakkamkandam" to Rs.0.50 Cr. from Rs.4.50 Cr. for the purchase of septage vehicles, and the transfer of the balance amount of Rs.4.00 Cr. to the new sewerage / septage proposals in other ULBs.
- 3.Government have examined the matter in detail and are pleased to accord Sanction to cancel the work of Septage Treatment Plant at Chakkamkandam subject to the following conditions:
- 1) The amount of Rs.0.50 Cr. set aside in the DPR for the collection & conveyance of septage shall be utilized for the purchase of septage vehicles for the ULB.
- 2)The balance amount of Rs.4 Cr. shall be transferred to the new sewerage / septage proposals in other ULBs.
- 3)The expense incurred so far for the septage project shall be borne by the ULB.
