ORDER

As per letters read as 1st, 2nd and 3rd papers above, Ministry of Rural Development, Government of India sanctioned a total amount of ₹36,55,44,000/- (General - ₹14,63,64,000/-, SCP - ₹15,03,85,000/- and TSP - ₹6,87,95,000/-) as 2nd tranche of 1st Installment of Central assistance to the State for National Rural Livelihoods Mission (NRLM) for the year 2022-23. Being the implementing agency of NRLM in Kerala, the Executive Director, Kudumbashree, as per letter read as 4th

paper above, has requested to release a total amount of ₹60,92,40,000/-, including the Central share sanctioned along with its matching State share ₹24,36,96,000/-, from the current year's Budget allocation.

2.In the above circumstances, Government are pleased to accord sanction to release a total amount of ₹60,92,40,000/- (Rupees Sixty Crore Ninety Two Lakh and Forty Thousand only) to Kudumbashree as 2nd tranche of 1st installment of the Central share and its matching State Share for implementation of NRLM in the State for the year 2022-23, from the current year's Budget allocation, as detailed below:
