## **ORDER**

As supplement to the first report, Sixth State Finance Commission has recommended that in the case of disasters formally notified either by the State Government or by Government of India, Local Self Government Department in consultation with the Finance Department, could issue special orders permitting use of Road and Non-Road Maintenance Fund for other specifically identified items except that Non-Road Maintenance Fund should not be spent for roads.

As per order read as second paper above, Government have approved Orange Book -2022 of Kerala Disaster Management Authority and it has been stipulated that if the Local Self-Government does not have funds available for the work of laying sand-filled rope bags/Geo tubes, funds can be utilized from the head of account 2245-02-101-94-Flood-Other items. It has also been provided that in respect of disaster waste disposal in recognized disaster-affected local bodies, the districts may find funds from the head of account 2245-02-101-94-Flood-Other items.

In the above circumstances, Government have examined the matter in detail and are pleased to permit the use of Road and Non-Road Maintenance Fund for other specifically identified items in the case of Disasters formally notified either by the State Government or by Government of India in consultation with the Finance Department except that Non-Road Maintenance Fund should not be spent for roads. At the same time Road Maintenance Fund could be spent for Non-Road Maintenance.
