ORDER

As per the Government Order read as 1st above, Shri. Sananda Singh B was appointed as Municipal Secretary Grade-III and he joined duty on 01,03.2019 AN. The Principal Accountant General (A&E) vide letter read as 2nd above has reported that he has not availed any leave other than casual leave during the period of probation.

The period of probation in the cadre of Municipal Secretary Grade III is two years duty within a continuous service period of three years. Hence the period of probation in respect of Shri. Sananda Singh B, Municipal Secretary Grade III is from 02.03.2019(he assumed charge on 01.03.2019 AN) to 01.03.2021.

The Director of Urban Affairs has recommended the application of the incumbent for declaring probation as per letter read as 3rd above and also reported that the work and conduct of the applicant is good and no disciplinary proceedings/vigilance case is pending against the applicant during the period of probation.

Director, LSGD (Urban) also reported that he has not acquired the

prescribed qualification of passing departmental test for declaration of probation. He attained 50 years of age on 04.05.2021 and is exempted from passing obligatory tests.

Persons who attained the age of 50 years are exempted from passing departmental tests except those which are prescribed as essential qualification in the Special rules for promotion and probation as per G.O.(MS) No.282/81/GAD dated 26.08.1981 and hence his probation is extended upto 04.05.2021.

Government have examined the matter in detail and are pleased to declare that the period of probation in respect of Shri.Sananda Singh B, Municipal Secretary in the cadre of Municipal Secretary Grade III as satisfactorily completed with effect from 05.05.2021 FN as per Rule 20 (b) of General Rules of KS&SSRs.
