ORDER

Vide Order read as first paper above Administrative Sanction was accorded for construction of STPs in various LSGIs with financial assistance of Rs.150Cr from KIIFB and M/s IMPACT Kerala Ltd (IKL) as the Special Purpose Vehicle for implementation. Government also issued Administrative Sanction for an amount of Rs.11.40Cr from within the said allocation for "Construction of 1.5 MLD Sewage Treatment Plant with sewer network for Ottappalam Municipality"

vide Order read as 2nd paper above. IMPACT Kerala Ltd issued Technical Sanction for the same for an amount of Rs.12.85 crore (hike due to DSR revision) vide Proceedings read as 3rd paper above.

IMPACT Kerala Ltd. invited tender for the project on 'Design-Build-Operate' mode with 'Open Technology' for Design, Engineering, Procurement, Construction, Erection, Commissioning and Operation and Maintenance for a period of 10 years after its successful commissioning. The bid price for the project is the total of construction cost as well as O&M cost for 10 years. Two tenders were received on first tender attempt but since none of the bids were technically qualified, the work was re tendered. Only one bid was received on re tender and that was submitted by M/s Micheal and Micheal Pipes Pvt.Ltd, Ernakulam as Lead bidder with M/s KSP Hydro Engineers Pvt Ltd, Jaipur and M/s Vardhman Engineering works, Delhi as JV Partners. The bid was found technically qualified and the Technical Committee of IKL held on 26.10.2022 decided to accept it and the financial bid was opened on 28.10.2022. The construction cost quoted by the bidder was Rs.19,81,12,560/- which negotiation, the bidder reduced the rates as follows.

The 5th Tender Acceptance Committee of IKL on 13.12.2022, accepted the tender and directed IMPACT Kerala Ltd to obtain Government approval as stipulated in the Guidelines issued vide Order read as 5^{th} paper above. Managing Director, IMPACT Kerala Ltd vide letters read as 6^{th} paper above requested the Government to accept the tender at the negotiated quoted rate recommended by the Tender Acceptance Committee and to accord Revised Administrative Sanction for the negotiated construction cost along with 18% GST , which amounts to Rs.20,92,94,901/-.

Government examined the matter in detail and pleased to accept the tender for the work "Construction of 1.5 MLD Sewage Treatment Plant with sewer network for Ottappalam Municipality" by M/s Micheal and Micheal Pipes Pvt.Ltd, Ernakulam as Lead bidder with M/s KSP Hydro Engineers Pvt Ltd, Jaipur and M/s Vardhman Engineering works, Delhi as JV Partners at the negotiated rate of Rs.17,73,68,560/- as Construction cost and Rs.11,98,47,331/- as O&M charges for ten years. Government are also pleased to accord revised Administrative Sanction for the Project for amount of Rs.20,92,94,901/-(Rupees Twenty crores ninety two lakhs ninety four thousand nine hundred and one), the total project cost for construction including 18% GST, which is to be met from the financial assistance of KIIFB entitled vide Government Order read as first paper above.
