ORDER

Pradhan Mantri Grama Sadak Yojana (PMGSY) is an ongoing Centrally Sponsored Scheme and Government of Kerala provide an Additional State Share as an additional State support to the Scheme. As per G.O. read as 1st paper above, Government accorded Administrative Sanction for the Budgetary allocation of ₹20 crore for the year 2022-2023 under the head 4515-00-800-98(03). Government also accorded sanction to release an amount of ₹13,29,77,000/- as first installment of Additional State Share for PMGSY, as per the G.O. read as 2nd paper above.

2.The Member Secretary, KSRRDA, as per letter read as 3rd paper above, has requested to release the balance amount of Additional State Share for PMGSY ₹6.7023 crore, as the released amount was fully

utilized and KSRRDA is facing difficulty in honouring payments due.

3.Government have examined the matter in detail and are pleased to accord sanction to release an amount of ₹6,70,23,000/- (Rupees Six crore Seventy lakh and Twenty three thousand only) under the head of account 4515-00-800-98(03), as balance amount of Additional State Share for PMGSY scheme for the FY 2022-23.
