### ORDER

The Hon'ble Supreme Court appointed Justice (Rtd.) Siri Jagan Committee to decide on the compensation to be awarded to the victims of stray dog menace in Kerala. The Hon'ble Supreme Court in its judgment dated 16.07.2018 in CC No. 944/17 in WP (C) No. 599/15, read as 1<sup>th</sup> paper above ordered that it would be the obligation of the State to see that the compensation for stray dog victims as recommended by the Justice (Rtd.) Siri Jagan Committee is strictly complied with and if it is not complied with the competent authorities of the State shall be liable for contempt of the Supreme Court and be adequately punished. In compliance with the Court order, after disbursing compensation along with interest to the claimants upto 26<sup>th</sup> reports, an affidavit has already been filed before the Supreme Court on 15.06.2021.

As per letter read as 2<sup>nd</sup> paper above, the Secretary, Justice (Rtd.) Siri Jagan Committee has furnished 34<sup>th</sup> to 36<sup>th</sup> report which recommended the payment of compensation to the victims with interest

@ 9% from the date of claim till payment.

Government have examined the matter in detail and sanction is accorded to the Secretaries of the local bodies concerned to pay the compensation awarded by the Commission to the following claimants in the 34<sup>th</sup> to 36<sup>th</sup> report of the Justice (Rtd.) Siri Jagan Committee with interest @ 9% per annum from the date of claim till payment.

A detailed compliance report in this regard shall be submitted to Government by Director of Panchayat / Director of Urban Affairs through Principal Director ,LSGD,within 15 days from the date of receipt of this Government Order.
