### ORDER

Government of India, vide letter read as 1<sup>st</sup> paper above, have released an amount of ₹297,78,88,000/- (Rupees Two Hundred Ninety Seven Crore Seventy Eight Lakh and Eighty Eight Thousand Only) to the Government of Kerala being the 2<sup>nd</sup> installment of 1<sup>st</sup> tranche of Central Assistance towards Material Component and Administrative Contingency for implementation of MGNREGA for the financial year 2022-23. This amount includes ₹224,72,50,000/- as Material component and ₹73,06,38,000/- as Administrative component.

2.The Mission Director, MGNREGS State Mission, vide letter read as 2<sup>nd</sup> paper above, has submitted a proposal for releasing a total amount of ₹ 3,72,69,71,000/- towards Central Assistance now received along with its corresponding State Share (₹74,90,83,000/-).

3.Government have examined the matter in detail. The balance amount currently available in the current year budget allocation is insufficient to release the whole amount. In the circumstances, Government are pleased to accord sanction to release the available

amount ₹309,97,45,000/- (Rupees Three hundred and nine crore Ninety seven lakh and Forty five thousand only) being the partial release of 2<sup>nd</sup> installment of 1<sup>st</sup> tranche of Central Assistance for the financial year 2022-23 along with its State Share towards Material and Administrative components for the implementation of MGNREGA in the State, from the current year budget provision, as shown below:
