ORDER

As per the letter read as 1st paper above Ministry of Rural Development (MoRD), Government of India sanctioned an amount of ₹ 15,54,90,000/- as Central assistance to the State of Kerala under Shyama Prasad Mukherji Rurban Mission (SPMRM). Being the implementing agency of the Scheme in Kerala, the Commissioner for Rural Development, as per the letter read as 2nd & 3rd papers above, has requested to release the Central assistance along with the matching State Share (40%) for implementation of the Scheme.

2) Government have examined the matter in detail and are pleased to accord sanction to release a total amount of ₹25,91,50,000/- (Rupees Twenty Five Crore Ninety One Lakh and Fifty Thousand only) to the

Commissioner for Rural Development for the implementation SPMRM in Kerala subject to the conditions stipulated by MoRD as per the letter read as 1st paper above, from current year current year's budget provision as detailed in the table below:
