ORDER

Government of India, vide letter read as 1st paper above released an amount of ₹297,78,88,000/- (Rupees Two Hundred Ninety Seven Crore Seventy Eight Lakh and Eighty Eight Thousand Only) to the Government of Kerala being the 2nd installment of 1st tranche of Central Assistance towards Material Component and Administrative Contingency for implementation of MGNREGS for the financial year 2022-23. This amount included ₹2,24,72,50,000/- as Material component and ₹73,06,38,000/- as Administrative component.

2.The Mission Director, MGNREGS State Mission, vide letter read as 2nd paper above submitted a proposal for releasing a total amount of ₹3,72,69,71,000/- being the Central Assistance now received along with its corresponding State Share (₹74,90,83,000/-). As sufficient balance was not available in the concerned heads of account in the current year budget allocation to release funds as per the proposal,

sanction was accorded for partial release of funds to the tune of ₹3,09,97,45,000/- (Rupees Three hundred and nine crore Ninety seven lakh and Forty five thousand only) as per the Government order read as 3rd paper above.

3. Meanwhile, additional authorisation has been sanctioned as per the Government order read as 4th paper above for an amount of ₹62,72,26,000/- in order to release the balance amount.

4. In the above circumstances, Government are pleased to accord sanction to release ₹62,72,26,000/- (Rupees Sixty two crore Seventy two lakh and Twenty six thousand only) being the balance amount of 2nd installment of 1st tranche of Central Assistance for the financial year 2022-23 along with its State Share towards Material components for the implementation of MGNREGS in the State as shown below:
