## <u>ORDER</u>

As per the letter read as 1<sup>st</sup> paper above, Ministry of Housing and Urban Affairs Department, Government of India has released an amount of Rs. 148,73,81,000/- (Rupees One Hundred Forty Eight Crore Seventy Three Lakh Eighty One Thousand Only) towards 1st instalment (20%) of AMRUT 2.0 for the implementation of the projects approved under State Water Action Plan (SWAP -1) of Kerala.

As per the letter read as  $2^{nd}$  paper above Mission Director, AMRUT has requested to accord sanction for the release of an amount of Rs.103,31,34,700/-, through additional authorization under dedicated heads of account, to provide funds in advance towards ULB share corresponding to the central share sanctioned for the implementation of SWAP 1 under AMRUT 2.0

3. As per GO read as 3<sup>rd</sup> paper above, an additional expenditure to the tune of Rs. 103,31,36000/- (Rs.
