ORDER

Sanction was accorded to Urban Local Bodies, vide Government Order read above, for developing Micro Water Supply Schemes by availing the services of KWA/ Ground water Department/ CWRDM/ Jal Nidhi /Accredited Agencies/ Empaneled Implementation Support Agencies for implementation of Jal Jeevan Mission (JJM), for project preparation of Micro Water Supply Projects under AMRUT 2.0.

As per the letter read as 3 rd paper above, Mission Director, AMRUT reported that the State Level High Powered Steering Committee (SHPSC) of AMRUT 2.0 had approved a list of 58 Implementation Support Agencies (ISAs).
