ORDER

As per letter read as 1st paper above, Ministry of Rural Development, Government of India have released an amount of ₹100,00,00,000/- (Rupees Hundred Crore only) as Central Share of 1st tranche of 1st instalment of Programme fund under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State Government for the financial year 2022-23. The corresponding State Share comes to ₹68.24 crore. However, an amount of ₹44.45 crore had been received from Government of India as part of 'Scheme for Special Assistance to the State for Capital Investment' and this amount has to be treated as State Share of PMGSY. Hence, the balance amount of State Share to be released is ₹23.79 crore. Accordingly, as per the letter read as 2nd paper above, the Member Secretary, KSRRDA has requested to release a total amount of ₹123.79 crore to the SNA account of PMGSY.

2)In the above circumstances, Government are pleased to accord sanction to release a total amount of ₹123,79,00,000/- (Rupees One

hundred and Twenty Three Crore Seventy Nine Lakh only) towards Central share and balance State share of 1st tranche of Ist installment of Programme fund under PMGSY for the year 2022-23, as shown below:
