## <u>ORDER</u>

As per the release order read as 1st paper above, MoHUA, Government of India have sanctioned a total amount of Rs. 49 Crore as the balance amount of 2nd installment of Project fund and A& OE fund for development of Thiruvananthapuram as Smart city under Smart Cities Mission(SCM) as follows:-

Project Fund sanctioned Rs. 46.5 Crore A&OE Fund sanctioned Rs. 2.5 Crore Total Fund sanctioned Rs. 49 Crore (Rs 46.5 Cr+ Rs 2.5 Cr)

2. As per the letter read as 2nd paper above, CEO, Smart City Thiruvananthapuram Limited has requested Government to release the amount of Rs. 49 Crore sanctioned as central share along with matching State share of Rs.49 Crore.
