ORDER

As per the letter read as 1st paper above, Government of India had sanctioned, a total amount of ₹36,55,44,000/- (General - ₹14,63,64,000/-, SCP - ₹15,03,85,000/- and TSP - ₹6,87,95,000) as the 1st tranche of 2nd installment of the Central share for the implementation of National Rural Livelihood Mission (NRLM) for the year 2022-23. The matching State share (40%) comes to ₹24,36,96,000 (General - ₹9,75,76,000/- SCP- ₹10,02,56,667/- and TSP - ₹4,58,63,333/-).

2. Being the implementing agency, the Executive Director, Kudumbashree as per the letter read as 2nd paper above, has requested to release the Central share sanctioned along with the matching State share from the current year's Budget allocation of NRLM.

3. Government have examined the matter in detail. The total amount to be released including State share is ₹60,92,40,000/-. But, the balance amount available under the heads of account of TSP component of

NRLM is not sufficient to release the full amount. In the circumstances, Government are pleased to accord sanction to release a total amount of ₹53,39,15,667/- (Rupees Fifty three crore Thirty nine lakh Fifteen thousand Six hundred and sixty seven only) as the 1st tranche of 2nd installment of the Central share along with the corresponding State share for the year 2022-23 for the implementation of NRLM in the State, from the current year Budget provision as shown below:
