ORDER

As per GO read as 1 st paper above, revised administrative sanction was accorded for an amount **Rs.11.27 Cr** for the work "Multi Level Car Parking (MLCP) at Stadium Premises and Bank Road" under Urban Transport Sector being implemented by Kannur Municipal Corporation.

- 2. 5th meeting of State Level High Powered Steering Committee of AMRUT considered proposal submitted by the Secretary, Kannur Municipal Corporation for the revision of Administrative Sanction for the work "Multi Level Car Parking (MLCP) Complex at Stadium Premises and Bank Road" due to the following reasons;
 - At the Stadium site due to the presence of an Underground BSNL duct, 4 footings had to be redesigned. The sump, pump room, overhead tank, and Firefighting system also had to be redesigned as per the site conditions.
 - At the Bank Road site due to insufficient area, the sump and pump room have to be redesigned.
 - Changes had to be made in the estimate of electrical works for obtaining clearance from Electrical Inspectorate.
 - A boom barrier also had to be added in the estimate at the stadium premises.
 - Due to these changes an excess amount of Rs.1.29 Cr. is required (inclusive of 18% GST)
 - 3. As per the minutes read as 2^{nd} paper above, 5^{th} meeting of SHPSC

has decided as follows

- * The Committee accorded sanction to revise the Administrative Sanction of the work, "Multi Level Car Parking (MLCP) Complex at Stadium Premises and Bank Road," from Rs.1l.27 Cr. to Rs.12.56 Cr.
- * The required additional amount (Rs.1.29 Cr.) shall be met from the savings available in the Urban Transport sector works/ Own fund.
- * Any financial implications due to the non-completion of the works by 31.03.2023 shall be borne by the ULB.
- 4. As per the letter read as 3 rd paper above, Mission Director, AMRUT has requested to accord revised Administrative Sanction for the work, "Multi Level Car Parking (MLCP) Complex at Stadium Premises and Bank Road," based on the decision of 5th SHPSC
- 5. Government have examined the matter and are pleased to accord revised Administrative Sanction for an amount of **Rs.12.56 Cr.** for the work, "Multi Level Car Parking (MLCP) Complex at Stadium Premises and Bank Road," being implemented by Kannur Municipal Corporation under Urban Transport Sector of AMRUT, subject to the following conditions
 - The required additional amount (**Rs.1.29 Cr.**) shall be met from the savings available in the Urban Transport sector works/ Own fund.
 - Any financial implications due to the non-completion of the works by 31.03.2023 shall be borne by the ULB.
