ORDER

As per letter read as 1st paper above, Ministry of Rural Development, Government of India have released an amount of ₹5,92,01,000/- for "Financial Incentive" as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State Government for the financial year 2022-23. As per the letter read as 2nd paper above, the Member Secretary, KSRRDA has requested to release a total amount of ₹9,87,01,000/- towards the aforesaid Central assistance and corresponding State share ₹3,95,00,000/- to the SNA account of PMGSY.

2. Government have examined the matter in detail and are pleased to accord sanction to release a total amount of ₹9,87,01,000/- (Rupees Nine Crore Eighty Seven Lakh and One Thousand only) as Central share and corresponding State share of Financial incentive under PMGSY for
