### **ORDER**

As per the letters read as 1st paper above, Government of India had sanctioned, a total amount of ₹36,55,44,000/- as the Ist tranche of 2nd installment of the Central share for the year 2022-23 for the implementation of National Rural Livelihood Mission (NRLM), in which TSP component was ₹6,87,95,000/-. The total amount to be released including State share was ₹60,92,40,000/-. Due to the insufficient balance in the last year's budget provision under the H/A of TSP component, only a total amount of ₹53,39,15,667/- could be released as per Government Order read as 2nd paper above. In the circumstances, the Executive Director, Kudumbashree as per the letter read as 3rd paper above, has requested to release the balance amount of TSP from the current year's Budget allocation of NRLM.

2.Government have examined the matter in detail and are pleased to accord sanction to release an amount ₹7,53,24,333/- (Rupees Seven crore Fifty three lakh Twenty four thousand Three hundred and thirty

three only) as the balance amount of 1<sup>st</sup> tranche of 2<sup>nd</sup> installment of the Central share and matching State share under the TSP component for the year 2022-23 for the implementation of NRLM in the State, from the current year's budget provision as shown below:
