The Director (A&F) State Poverty Eradication Mission (Kudumbasree) has certified that the work and conduct of the applicant is good. The Principal Accountant General (A&E), Kerala has reported that the Officer has not availed any leave other than casual leave during the period of probation. The period of probation in the post of Corporation Secretary is six months duty within a continuous service period of one year. Hence the period of probation in respect of Shri. S.Jahamgeer, Corporation Secretary is from 22.01.2021 to 21.07.2021. The disciplinary action initiated against him as per memo of charges No.EU1/243/2020/LSGD dated 13.08.2019, was finalised by

exonerating him from all the charges levelled against him vide G.O (Rt) No.899/2023/LSGD dated 20.04.2023. No other case is pending against him.
