### ORDER

The Mission Director, Amrut, as per the letter read as 1<sup>st</sup> paper above,  
has informed that the proposal of Thiruvananthapuram Corporation for  
issuance of Administrative Sanction for the following 3 new works was  
placed in the 32<sup>nd</sup> SHPSC for approval.

1) Laying transmission main and sewer networks in Block L – laying of  
315mm dia HDPE transmission main from Ulloor Jn to SN Jn in Ulloor  
- Akkulam road by HDD method.

Sector: SEW

AS Amount Required: Rs.4.91 Cr.

2) Laying transmission main and sewer networks in Block L – Laying  
of 315 mm dia HDPE Transmission main from Kumarapuram towards  
Kunjuveed Jn of Poonthi Road by HDD method

Sector: SEW

AS Amount Required: Rs.4.97 Cr.

3) Providing sewerage system for Puthenpally Ward and Muttathara  
Ward (part)

Sector: SEW

AS Amount Required: Rs.48.37 Cr.

2)The Committee decided to accord sanction for 2 SEW works subject to the following conditions:

- (i) The required amount shall be met from the overall savings available in AMRUT-1.0 projects of the Thiruvananthapuram Corporation.
- (ii) Additional financial implication shall be borne by the ULB.
- (iii) Approval of the Council shall be obtained.

The KWA shall discuss alternative sewerage works instead of the Rs.48.37 Cr., sewerage work with the ULB and shall jointly take up feasible sewerage works that can be immediately started.

3) Government have examined the matter in detail and are pleased to accord Sanction for the following 2 SEW works subject to the conditions noted below:

- (i) Laying transmission main and sewer networks in Block L – laying of 315mm dia HDPE transmission main from Ulloor Jn to SN Jn in Ulloor - Akkulam road by HDD method

- (ii) Laying transmission main and sewer networks in Block L – Laying of 315 mm dia HDPE Transmission main from Kumarapuram towards Kunjuveed Jn of Poonthi Road by HDD method

AS Amount Required: Rs.4.97 Cr

Conditions:

- (i) The required amount shall be met from the overall savings available in AMRUT-1.0 projects of the Thiruvananthapuram Corporation.
- (ii) Additional financial implication of the works shall be borne by the ULB.
- (iii) Approval of the Council shall be obtained.

The KWA shall discuss alternative sewerage works instead of the Rs.48.37 Cr., sewerage work with the ULB and shall jointly take up feasible sewerage works that can be immediately started.
