As his continuance in the Commission as consultant is felt to be absolutely necessary, he has been engaged by the Commission in the same duty for a further period of four spells from 03.06.2019 to 31.05.2021 (ie from 03.06.2019 to 02.12.2019, 03.12.2019 to 02.06.2020, 03.06.2020 to 02.12.2020 and 03.12.2020 to 31.05.2021) as per proceedings read as 3rd paper above and requested Government to ratify the appointment of Shri. Radhakrishna Kurup.C as consultant in the State Election Commission, Kerala, made in four spells up to 31.05.2021 .
