## <u>ORDER</u>

Smt.Sajini P.K. Hospital Attendant Gr.II at the District Hospital. Kozhencherry in Pathanamthita, while working as Part Time Casual Sweepr in Aranmula Grama Panchayt from 03.02.1996 had filed WP(C) No.24758/2008 before Hon'ble High Court with a prayer to regularize her service in accordance with the provisions of GO(P)No501/2005/Fin dated 25.11.2005. Pursuant to the directions of Hon'ble High Court to grant the benefit of the above GO along with monetary benefits, Government as per the GO read as 2<sup>nd</sup> paper above, have regularised her service in the existing vacancy of Part Time Sweeper in Aranmula Grama Panchayat w.e.f the date of issue of the order. Being denied the benefit of regularisation retrospectively w.e.f 03.02.1996 (date of her original appointment) or at least w.e.f 18.06.2001( date contemplated in GO dated 25.11.2005) the applicant filed OA No 589/2019 before Hon'ble Kerala Administrative Tribunal.

2. The Hon'ble Kerala Administrative Tribunal as per judgment read as 3 <sup>rd</sup> paper above has disposed of the OA by quashing the GO read as 2<sup>nd</sup> above to the extent it limits the benefit of regularisation to the date of order,ie, 28.05.2010 and declared that the applicant is entitled for the benefits of Annexure A3 order as held by the Hon'ble High Court in Annexure A1 Judgment and for all the benefits flowing there from.

- 4. Government have examined the matter in detail. As per G.O. read as 1<sup>st</sup> paper above, casual sweepers continuously engaged as on 25.11.2005 in an office having a sweeping area of 100 sq metre or above are eligible for regularisation in the post of Part Time Sweeper. The posts shall be created with effect from the date of appointment of incumbent as casual sweeper or from 18/06/2001 whichever is later. The final judgement in WPC No. 24758/2008 clearly specifies that the petitioners were entitled for such benefit that are applicable as per the G.O. read as 1<sup>st</sup> paper above along with monetary benefits. Accordingly Smt. Sajini.P.K is eligible for regularization in all respects from 18/06/2001 on the post of Part Time Sweeper in Aranmula Grama Panchayat.
- 5. After having examined the matter in detail, Government are pleased to regularize the appointment of Smt. Sajini. P.K in the post of Part Time Sweeper in Aranmula Grama Panchayath w.e.f 18/06/2001.
- 6. The Order read 3rd paper above of the Hon'ble Kerala Administrative Tribunal is complied with accordingly.
