ORDER

NUDM aims to support States and Union Territories (UTs) in the electronic delivery of municipal services, and supplement the digital initiatives of the State/UT Governments and also to ensure that citizens are provided with the best possible services through online/ digital mode and that the best practices are replicated across the country.
