ORDER

As per Government order read as 1st paper above, Administrative Sanction had been accorded for the balance works of two roads viz, Devarupara-Naliyani Road and Perngasseri Cheppukulam Road of Package No. KR-03-27 Elamdesom Block, Idukki District under PMGSY 2008-2009 Phase VII, for an amount of ₹4,87,39,823/-. In these works, estimate was prepared incorporating GST with 12%. As the applicable rate of GST has increased to 18% w.e.f. 18th July, 2022, the Chief Engineer, KSRRDA as per letter read as 3rd paper above, has requested for revised Administrative Sanction for the above work for an amount of ₹5,16,64,213/-.

2) Government have examined the matter in detail. The Chief Engineer, KSRRDA has reported that the cost enhancement is due to hike in the GST rates alone. Hence, Government are pleased to accord revised Administrative Sanction for the balance works of Devarupara-Naliyani Road and Perngasseri Cheppukulam Road of Package No.KR-03-27 Elamdesom Block, Idukki District under PMGSY 2008-2009 Phase VII, for an amount of ₹5,16,64,213/- (Rupees Five crore Sixteen

lakh Sixty four thousand Two hundred and Thirteen only), based on the circular read as 2nd paper above.
