AMRUT 2.0 - Cancellation of the project for Construction of a new Overhead Service Reservoir (OHSR) of 15 lakh litre capacity at the Fort Kochi tank site for an amount of Rs.4.15 Cr and the replacement project for 5 lakh litres CAPACITY GLSR (Ground Level Service Reservoir), pump house, and supply and installation of pump set at Edakochi OHSR for an amount of Rs.2.602 Cr. - Sanction accorded - Orders issued

ORDER

Kochi Municipal Corporation has submitted 26 water supply projects for an amount of Rs. 163.75 Cr under the 1st and 2nd tranches of State Water Action Plan (SWAP) of AMRUT 2.O. "Construction of a new Overhead Service Reservoir (OHSR) of 15 lakh litre capacity at the Fort Kochi tank site" for a CAPEX amount of Rs.4.15 Cr under SWAP 1 was one of the projects approved by the 4th Apex Committee meeting of AMRUT 2.0. During a subsequent inspection by Kerala Water Authority (KWA) it was found that the proposed site did not have enough space to accommodate the proposed OHSR. Kochi Municipal Corporation and KWA decided to replace this project with another project "The construction of a 5 lakhs litre capacity Ground Level Service Reservoir (GLSR), pump house, and supply and installation of pump set at Edakochi OHSR" for CAPEX Rs.2.496 Cr.

2. As per the minutes read as 1st paper above, 6th State Level High Powered Steering Committee of AMRUT 2.0 has decided to accorded sanction to the cancellation of the project - Construction of a new OHSR of 15 lakh litres capacity at the Fort Kochi tank site for Rs.4.15 Cr. (CAPEX – Rs.4 Cr. & OPEX - Rs.0.15 Cr.) and the replacement project – AMRUT 2.0- 5 lakh litres CAPACITY GLSR (Ground Level Service Reservoir), pump house, and supply and installation of pump set at Edakochi OHSR for Rs.2.602 Cr. (CAPEX – Rs.2.496 Cr. & OPEX - Rs.0.106 Cr.)

3.As per the letter read as 2nd paper above, Mission Director, AMRUT has requested to accord sanction based on the decision of SHPSC.

4.Government have examined the matter and are pleased to accord sanction to the cancellation of the project - Construction of a new Overhead Service Reservoir (OHSR) of 15 lakh litre capacity at the Fort Kochi tank site for an amount of Rs.4.15 Cr. (CAPEX - Rs.4 Cr. & OPEX - Rs.0.15 Cr). Government is also pleased to accord Administrative Sanction for the replacement project – AMRUT 2.0 - 5 lakh litres CAPACITY GLSR (Ground Level Service Reservoir), pump house, and supply and installation of pump set at Edakochi OHSR for an amount of Rs.2.602 Cr. (CAPEX – Rs.2.496 Cr. & OPEX - Rs.0.106 Cr.)
