ORDER

The provisional seniority list of Executive Engineers upto the period 31.12.2022 in respect of LSGD Engineering wing was published as per Notice read as 1st paper above. The Chief Engineer,LSGD, vide letter read as 4th above, has forwarded the provisional seniority list along with details of objections and report thereon for finalisation of the same.

In order to examine the above objections in detail, the petitioners who raised objections were heard by Govt on 14.07.2023 in the presence of concerned officers , o/o the CE . The petitioners by submitting detailed statements and appended documents establishing their claims have flagged their issues specifically . The crux of their objections , the facts thereon and the final conclusion are summarised as follows ;

(1) **Smt. Shainy N, Executive Engineer:-** The incumbent has raised an objection on her position in the draft seniority list of Executive Engineers. She claims that her position in the draft seniority list of

Executive Engineers is not in accordance with her position in the Final Seniority List of Assistant Executive Engineers published vide GO(Rt)No.2283/2021/LSGD dated 16.11.2021 . She has requested to include her as Sl.No.9 (Rank No.51) instead of Sl.No.44 (Rank No.86) in the draft seniority list of Executive Engineers as no disciplinary proceedings are pending against her.

The arguments of Smt. Shainy.N is not seen worthy as Sri. Valsan Padinjarepurayil, who is junior to Smt. Shainy N. in the final seniority list of Assistant Executive Engineers published vide GO(Rt)No.2283/2021/LSGD dated 16.11.2021 , was included in the Select list 2019 for promotion to the post of Executive Engineer and was promoted thereafter. Smt. Shainy N was superseded in the Select list 2019 for promotion to the post of Executive Engineer due to the pendency of disciplinary action for minor penalty initiated against her in three cases as per VACB recommendation. She was superseded in the Select list for the year 2020 as well for promotion to the post of Executive Engineer due to the pendency of disciplinary action for major penalty. Select list 2021 for promotion to the post of Executive Engineer was not prepared as the seniority list of Assistant Executive Engineers was not finalised. The then DPC(H) 2022 held on 10.05.2022 decided to include the petitioner in Select list 2022 for promotion to the post of Executive Engineer as the two disciplinary actions pending against her were finalised vide GO(Rt)No.336/2022/LSGD dated 15.02.2022 and G.O(Rt)No.10/2022/LSGD dated 03.01.2022 respectively by giving censure. Consequently, she was promoted to the post of Executive Engineer vide GO(Rt)No.1312/2022/LSGD dated 26.05.2022. As such her seniority was fixed in the draft seniority list of Executive Engineers with effect from the date of her promotion ie, 26.05.2022.

(2) **Smt. Gigi Thomas, Executive Engineer:-** The incumbent has raised an objection on her position in the draft seniority list of Executive Engineers. She claims that she ought to have been included in the 13th position of the draft seniority list of Executive Engineers in light of the clearance of disciplinary proceedings initiated against her.

The arguments of Smt. Gigi Thomas is also not seen considerable as she was superseded in the select list 2019 for promotion to the post of Executive Engineer due to the pendency of disciplinary proceedings initiated against her for major penalty. She was again superseded in the select list of 2020 for promotion to the post of Executive Engineer due

to the pendency of disciplinary action for major penalty against her in two cases. Later, DPC(H) 2022 held on 10.05.2022 decided to include her in Select list of AEE for the year 2022 for promotion to the post of Executive Engineer with the remarks that she will be eligible for promotion only after the currency period of penalty ie, being impugned after on 13.09.2022. Consequently, she was promoted to the post of Executive Engineer vide GO(Rt)No.3139/2022/LSGD dated 19.12.2022. As such her seniority was fixed in the draft seniority list of Executive Engineers with effect from the date of her promotion to the cadre of EE ie, 19.12.2022.

In the above circumstances, as the arguments put forth by the following read as 2nd & 3rd paper above are not worth considering, the case is disposed of as detailed above. Hence, Government are pleased to approve the final Seniority List in the cadre of Executive Engineers of LSGD Engineering wing upto 31.12.2022 as annexed to this order and ordered to publish the same.
