# <u>ORDER</u>

The Ministry of Panchayati Raj, Government of India, has developed a mechanism for measuring the progress of Panchayats in achieving the Localized Sustainable Development Goals (LSDG) along nine individual themes as well as computing the composite progress as an aggregate of nine themes of LSDGs. Panchayat Development Index (PDI) will assess the performance of Panchayats on measurable indicators of Local Indicator Framework (LIF) and help the Panchayats in evidence-based planning for outcome-oriented development goals. In short, PDI is the report card of progress of Panchayats and scales up the visibility of development at the grassroots. The report on PDI was released by MoPR.

2. PDI is a data intensive work. The entire computation exercise requires collection of data by the frontline workers of the line department in different registers/formats, and maintenance of data sets by Grama Panchayats and field offices of line departments. There is a heavy reliance on data from multiple sources due to wide range of local indicators required to cover the LSDGs. The data of Grama Panchayats thus entered is subjected to rigorous validation at different levels before computation of thematic and composite PDI scores. Hence proactive

participation of State Departments, along with Union Ministries is essential for implementing PDI framework, by facilitating quality data collection and validation. The baseline report of the PDI will serve as the benchmark to support the MoPR/Department in monitoring and evaluating the progress towards target of SDGs.

3. Citing the above details, the Secretary, MoPR, has requested vide paper read 1st above, to initiate capacity building of stakeholders, by organizing the State Level Workshop/Write-shop involving all the stakeholders from different line departments and the State Technical Team. It is also requested to assign clear cut roles to the officials/ PRIs/ stakeholders at all levels and to appoint a State Level Nodal Officer for PDI and also to constitute a Steering Committee at the State level with representation of the Senior Officers of the key line departments and Monitoring and Data Validation Committees at District, Sub-Division & Block level.

4. Government have examined the matter in detail and are pleased to nominate Smt. Josnamol S., Joint Director, Principal Directorate, LSGD, as State Level Nodal Officer for coordinating activities related to PDI in the State. State Level Steering Committee, State Level Data Validation Team, District Level Monitoring Committee, District Level Validation Team, Sub Divisional Level Monitoring Committee and Block Level Data Validation team are also constituted to facilitate data collection and validation as envisaged in PDI framework, with structure annexed hereunder. Also, KILA is entrusted with organising the State Level Workshop/Write-shop involving all the stakeholders from different line departments and the State Technical Team, in order to provide opportunity to the Departments and other stakeholders to share their preparedness, strategic institutional mechanisms, and plans of action in collection of data points from different sources.
