### **ORDER**

As per the letter read as 1<sup>st</sup> paper above the Ministry of Rural Development (MoRD), Government of India had sanctioned a total amount of ₹2,93,00,000/- (General component ₹2,63,00,000/- and SCP component ₹30,00,000/-) as 1<sup>st</sup> tranche of Central share for the year 2023-24, for implementation the projects under Watershed Development Component of Pradhan Mantri Krishi Sinchayee Yojana 2.0 (WDC-PMKSY 2.0). The Principal Director, LSGD, as per the letter read as 2<sup>nd</sup> paper above, has requested to release the Central share along with its matching State share, which comes to a total amount of ₹4,88,33,333/- (Central Share ₹2,93,00,000/- and State Share ₹1,95,33,333/-), from the current year's Budget allocation.

2.Government have examined the matter in detail and sanction is accorded to release a total amount of 4,88,33,333/- (Rupees Four crore Eighty eight lakh Thirty three thousand Three hundred and Thirty three only) as 1<sup>st</sup> tranche of Central share for 2023-24 and its corresponding State share for implementation the projects under WDC-PMKSY 2.0 in
