ORDER

FIFN - Laying of HDPE pipe from Aruvikara to Peroorkada and construction of 10 MLD sump at Peroorkada for Rs. 99.662Cr. (CAPEX- Rs 94.915 Cr. & OPEX- Rs. 4.747Cr.) was one of the water supply projects of Thiruvananthapuram Municipal Corporation approved by 4th Apex Committee meeting of the AMRUT 2.0 under the 1st tranche of SWAP of AMRUT 2.0.

2. As Kerala Water Authority (KWA) has reported that all the treatment plants are currently operating above the design capacity by way of over loading them, further overloading of the treatment plants is not possible and hence no additional treated water is available in any of the WTPs in Aruvikkara for supply to Thiruvananthapuram city, and no water is available for augmenting the water supply to Thiruvananthapuram city and also the existing pipelines have the carrying capacity to feed the treated water from Aruvikkara to Thiruvananthapuram city, Thiruvananthapuram Municipal Corporation has submitted proposals of two replacement projects amounting to Rs. 94.915 Cr for the consideration of State Level High Powered Steering Committee (SHPSC) of AMRUT-2.0.

3. 6th SHPSC has considered the two replacement projects of Thiruvananthapuram Municipal Corporation, and as per the minutes read as 1st paper above, the Committee has decided to accord sanction to cancel the project of FIFN - Laying of HDPE pipe from Aruvikara to Peroorkada and construction of 10 MLD sump at Peroorkada for Rs.99.662Cr. (CAPEX- Rs.94.915 Cr. & OPEX- Rs. 4.747 Cr.) and accord sanction for the following two replacement projects of Thiruvananthapuram Municipal Corporation:

i) AMRUT 2.0: Laying Transmission main M.S pipe from Peroorkada to Manvila including interconnection and allied works. - Rs. 66.1 Cr. (CAPEX Rs. 65.45 Cr. & OPEX- Rs.0.650 Cr.)

ii) AMRUT 2.0: TWSS - Providing Water Supply Distribution Network to Chandavila & Kattayikonam under Thiruvananthapuram - Rs. 30.935 Cr, (CAPEX- Rs 29.465 Cr. & OPEX- Rs. 1.470 Cr.)

4. The SHPSC has also decided to submit the above proposals to the Apex committee for approval since it exceeds 10% of the 1st tranche of SWAP and as per the minutes read as 2nd paper above, 8th Apex committee meeting for Atal Mission for Rejuvenation and Urban Transformation (AMRUT) has approved the project.

5. As per the letter read as 3rd paper above, Mission Director, AMRUT has requested to accord Administrative Sanction for the replacement project based on the decision of SHPSC.

6. Government have examined the matter in detail and are pleased to accord sanction for the cancellation of the project of Thiruvananthapuram Municipal Corporation- FIFN - Laying of HDPE pipe from Aruvikara to Peroorkada and construction of 10 MLD sump at Peroorkada for Rs.99.662Cr. (CAPEX- Rs 94.915 Cr. & OPEX- Rs. 4.747 Cr.). Government are also pleased to accord Administrative Sanction for the following two replacement projects of Thiruvananthapuram Municipal Corporation:-

i) AMRUT 2.0: Laying Transmission main M.S pipe from Peroorkada to Manvila including interconnection and allied works. - Rs. 66.1 Cr. (CAPEX Rs. 65.45 Cr. & OPEX- Rs.0.650 Cr.)

ii) AMRUT 2.0: TWSS - Providing Water Supply Distribution Network to Chandavila & Kattayikonam under Thiruvananthapuram - Rs. 30.935 Cr, (CAPEX- Rs 29.465 Cr. & OPEX- Rs. 1.470 Cr.)
