### ORDER

As per the letter read as 1<sup>st</sup> paper above, Ministry of Housing & Urban Affairs (MoHUA) has informed that an Agreement has entered into with the Singapore Cooperation Enterprises, an Agency of the Government of Singapore for a Capacity Building training covering understanding of water cycle including treatment and network management, treatment of used water, recycled water, application of asset management, good O&M practices and application of digital tools in water cycle management. MoHUA has also informed that they propose to organize four workshops/ capacity building training sessions in New Delhi and the training program will conclude with a five day visit to Singapore. The objective of the training is to 'Train the Trainers' who can in turn disseminate the learning to other colleagues in the State Governments and ULBs.
