ORDER

Shri.Viswanathan K. B while working as Municipal Secretary Gr III was transferred to Eriyad Grama Panchayath by the Order of the Principal Director read as 1st above. Sri.Viswanathan K B filed an appeal application read as 2nd above before Government against the order transferring him from the Chavakkad Municipality to Eriyad Grama Panchayath.

In the order dated 20.07.2023 in OA (EKM)No1209/2023 filed by Shri.Viswanathan K B, the Hon'ble Kerala Administrative Tribunal directed the Government to consider and pass orders on Annexure A6 appeal within a period of one month from the date of receipt of a copy of this order. The copy of the order received in this Department on 12.09.2023.

3. The Principal Director,Local Self Government Department vide letter read as 3rd above has reported that considering the request of the applicant, his transfer to Eriyat Grama Panchayat of Thrissur district has been cancelled and an order has been issued allowing transfer to Chalakudy Municipality of Thrissur District. The appeal Committee constituted for considering the appeal against general transfer also agreed to the above action of the Principal Director.

4. Government have examined the matter in detail. Since the Principal Director have issued Orders transferring Shri.Viswanathan K B to Chalakudy Municipality, the grievance of the appellant is redressed and hence no further action is necessary in his appeal petition read as 2nd above and accordingly closed the appeal.

5. The Order dated 20.07.2023 in OA (EKM)No.1209/2023 of the Hon'ble Kerala Administrative Tribunal is complied with accordingly.
