## **Abstract**

Local Self Government Department – PMGSY- Urgent maintenance work of the road in Package No.KR 10-86 Kokkad Othalur Malammakkavu road, Thrithala Block, Palakkad District - Administrative Sanction accorded – Orders issued.

## ORDER

The work in PMGSY package No. KR 10-86 Kokkad Othalur, Malammakkavu road was started in 07.01.2022 and the tarring work was completed for the entire length of 5.898 km. On 16.06.2023, an old DR masonry retaining wall, constructed by private owner on the side of the road at chainage 1/830 (RHS) was collapsed due to sub foundation failure/seepage and as a result, the side berm subgrade of the road slipped to the well situated very near to the retaining wall. Therefore the PIU officials inspected the site and found that in order to avoid the slippage in the road and to avoid further threaten to life, it is necessary to reconstruct the retaining wall, restore the embankment and construct pucca drains to prevent the infiltration of storm water.

- 2. In the above circumstances, the Chief Engineer, KSRRDA, as per letter read above, has furnished an estimate prepared in PRICE software, based on DSR 2018, for an amount of ₹20,38,560/- for the satisfactory completion of the urgent maintenance of the road in Package No.KR 10-86 in Palakkad District and requested to accord Administrative Sanction.
- 3. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the 'urgent maintenance work of the road in Package No.KR 10-86 Kokkad Othalur, Malammakkavu road, Palakkad District' for an amount ₹20,38,560/- (Rupees Twenty Lakh Thirty Eight Thousand Five Hundred and Sixty only), subject to the following conditions;

- i. TS authority shall review the retaining walls as per the Circular No.87/2016/Finance (Insp-tech) 18.11.2016 dated & No.64/2021/Fin dated 05.08.2021 considering economy and stability.
- ii. Technical Sanction authority shall verify all observed data proposed with actual execution methodology and least market rate and approve the same.
- The amount approved shall be used for the urgent iii. restoration/maintenance work proposed only and shall not be diverted/reappropriated for any other work/purpose, and savings obtained, if any, shall be kept unspent.
- 4. The expenditure for the aforesaid maintenance work can be met from the Head of Account '4515-00-800-98 (03) PMGSY Additional State Share'.
