ORDER

Ombudsman for Local Self Government Institutions is a Quasi Judicial Body constituted as per Section 271(G) of the Kerala Panchayat Raj Act, 1994. It was established in the year 2000 with the objective of inquiring into complaints regarding corruption and maladministration of elected representatives and officials of Local Self Government Institutions in the state. Within this short period, Ombudsman for Local Self Government Institutions has managed to obtain widespread acceptance of the society through its effective interventions in the functioning of Local Self Government Institutions.

- 2. During the period of 01-04-2020 to 31-03-2021, 427 Original Petitions have been filed before the Ombudsman, but camp sittings were not conducted during this period due to the outbreak of Covid-19 pandemic and the consequent lock-down and preventive measures adopted by Government. The number of cases disposed during the year under report was 76.
- 3. For the Financial year 2020-2021, an amount Rs. 1,73,21,000/-(Rupees One Crore Seventy Three lakhs and Twenty one thousand only) was provided in the budget for the Office of the Ombudsman for

LSGIs. Government have accorded sanction for the reappropriation of a sum of Rs.35,000/- under the Head of Account '2515-00-101-64-01-02-Wages' vide G.O.(Rt)No.211/2022/Fin, dated 11.01.2022. And an amount of Rs.44,39,000/- was surrendered during final settlement vide G.O.(Rt)No.3843/2022/Fin dated 30.04.2021

4. In the above circumstances, Government have reviewed the functioning of the office of the Ombudsman for Local Self Government Institutions during the year 2020-2021 and found satisfactory.
