ORDER

As per letters read as 1 to 3 above, the Ministry of Rural Development (MoRD), Government of India had sanctioned a total amount of ₹36,55,44,000/- (General - ₹32,18,62,000/-, SCP - ₹3,77,24,000/- and TSP - ₹59,58,000/-) to Government of Kerala, as the 1st tranche of 2nd installment of the Central share for the year 2023-24, for the implementation of National Rural Livelihoods Mission (NRLM)/Aajeevika in the State. Being the implementing agency of NRLM in Kerala, the Executive Director, Kudumbashree, as per letter read as 4th paper above, has requested to take necessary action to release a total amount of ₹60,92,40,000/-, which includes the aforesaid Central Share and its matching State share of ₹24,36,96,000/- (General - ₹21,45,74,667/- SCP - ₹2,51,49,333/- and TSP - ₹39,72,000/-).

2.Government have examined the matter in detail. As per Government Order read as 5th paper above, sufficient funds have been reappropriated to the the respective heads of account. In the circumstance, Government are pleased to accord sanction to release a total amount of ₹60,92,40,000/- (Rupees Sixty Crore Ninty Two Lakh and Forty

Thousand only) to Kudumbashree as 1st tranche of 2nd installment of Central share and its matching State Share for the year 2023-2024 for implementation of NRLM in the State, from current year's budget provision as detailed below:
