ORDER

As per the Government Orders read as 2 nd, 3 rd and 4 th papers above, Government had released the Central assistance received for the financial year 2023-24 to the State towards conducting Social Audit in the State and Staffing of independent Social Audit Unit. As per the letter read as 5 th paper above, an amount of ₹4,76,00,000/- has been sanctioned as part of 4 th installment of 2 nd tranche for the financial year 2023-24 to the State. The Director, MGNSASK, vide letter read as 6 th paper above, has requested to transfer credit the above amount to the SNA account of the Social Audit Unit bearing account no.37364716754 maintained at SBI Nanthancodu Branch.

2. Government have examined the matter. The Central assistance could not be transferred to the account of the Social Audit Society during the 2023-24 financial year, as the fund was received in the consolidated fund of the State during the last days of the previous financial year. In the circumstances, Government are now pleased to accord sanction to release an amount of ₹4,76,00,000/- (Rupees Four Crore and Seventy Six Lakh only) being the 4 th instalment of the Central Assistance for the financial year 2023-24 received towards conducting Social Audit in the State and Staffing of independent Social Audit Unit, from the current year's (2024-25) budget provision under the head of account 2505-02-101-97-34-3(PV).

3. The Controlling Officer of the above H/A shall take necessary steps to transfer credit the amount to the Account No.37364716754 (IFSC SBIN0007898) maintained by the Director, MGNREGA Social Audit Society Kerala
