ORDER

As per the letter read as 1st paper above, Ministry of Housing & Urban Affairs, Government of India has conveyed the release of an amount of 207,22,50,000/- (Rupees Two hundred and seven crores, twenty-two lakhs and fifty thousand only) to Government of Kerala as part payment of balance of eligible Central Assistance towards State Annual Action Plan (SAAP) I, II & III approved for the FY 2015-16,2016-17 & 2017-18, under Atal Mission for Rejuvenation and Urban Transformation (AMRUT 1.0).

As per the letter read as 2nd paper above, Mission Director, AMRUT has requested to release an amount Rs.331,56,00,000/- (Rupees Three hundred and thirtyone crores and fifty-six lakhs only) towards the balance central assistance and its matching state share for the projects as approved in State Annual Action Plan (SAAP) I, II & III for the FY 2015-16,2016-17 & 2017-18 under Atal Mission for Rejuvenation and Urban Transformation (AMRUT 1.0). The Mission Director has also requested to transfer and credit the amount to the single Nodal Account of AMRUT maintained by the Mission Director AMRUT with account number 6434109855 in Indian Bank, Thycaud

Branch (IFS Code: IDIB000T021)

3.As per G.O read as 3rd paper above, additional expenditure to the tune of Rs.331,56,00,000/- (Rupees Three hundred and thirty-one crores and fifty-six lakhs only) under the respective head(s) of account has been authorized to release the central assistance and its commensurate state share for settling the claims of the tendered projects as approved in the State Annual Action Plan (SAAPs) under AMRUT for the financial years from 2015-16 to 2017-18.
