### ORDER

The Chief Engineer, KSRRDA, as per letter read as 1st paper above, has requested to approve tender excess of 10 road works for a total amount of ₹8,98,06,360/-, as Tender Committee can not approve the same since the tender excess amount reached budget provisions earmarked for the year.

2.Government have examined the matter in detail. Out of the 10 works, 2 works, viz, package No.KR-11-80 in Pathanamthitta and package No.KR-14-31 in Wayanad, have quoted/negotiated amount within the DSR2018+10% limit of acceptance. But the other 8 works are quoted/negotiated above DSR2018+10%. As per the G.O. (P) No. 16/2017/Fin dated 06/02/2017, para 4(v), "If the quoted rate is still above allowable limit even after re-tendering, the competent authority shall rework the estimate, after giving due consideration to the site specific conditions and fresh tenders shall be invited based on revised estimates."

3. In the above circumstance, Government are pleased to approve the tender excess of the aforesaid 2 works for a total amount of ₹83,26,681/- (Rupees Eighty Three Lakh Twenty Six Thousand Six Hundred and Eighty One only) by meeting the expenditure from "4515-00-800-98(03) Additional State Share". For the balance 8 works, instructions have already been given vide the letter read as 2nd paper

above.

4. The Chief Engineer, KSRRDA shall ensure the correctness of the LMR calculation/tender excess calculation.
