ORDER

As per GO read as 1st paper above, Government had accorded Administrative sanction for conducting a LiDAR Survey to develop a Drainage Management Plan for the towns of Haripad, Mavelikkara, Adoor and Pathanamthitta at a cost of ₹3,00,00,000/- (Rupees Three crore only). The expenditure in this regard would be debited to the head of account 5475- 00-115-94-06 (P) (V) under the Rebuild Kerala Initiative.

2. As per GO read as 2nd paper above, Government have constituted a Joint Implementation Committee with 5 representatives from Water resources Department (DLI4 & DLI7 team) for effective monitoring and providing periodic updates of LiDAR Survey to RKI.

3. Due to a technical error crept in the e-tender issued on 16.03.2024, it was cancelled on 09.04.2024. As the Model Code of Conduct was in place, the work could be re-tendered only on 08.06.2024. The proposal submission deadline in the new tender is 04 July 2024. A pre-bid meeting has been held on 20 June 2024 with over 20 potential bidders.

4. As per clause 19.1 of Data Sheet of the RFP, "The Clients evaluation committee" shall conduct the opening of the Technical Proposals online following the procedure described in the Data Sheet.

5. RKI has forwarded the requested to constitute a Tender Evaluation Committee for a LiDAR Survey with representatives from KILA, PIU, the joint implementation committee and RKI as suggested below:
