## **ORDER**

Dr.S.Shanavas, Technical Officer, ICAR - CTCRI, Sreekaryam, Thiruvananthapuram was appointed as Programme Officer in Kudumbashree State Mission on deputation/ foreign service for a period of one year as per 2<sup>nd</sup> paper above, in accordance with the conditions stipulated in the NOC read as 1<sup>st</sup> above.

- 2. The Executive Director, Kudumbashree has furnished the proposal as per 3<sup>rd</sup> paper above for fixing the terms and conditions of foreign service of Dr.S.Shanavas in the post of Programme Officer, along with the LPC received from his parent Department.
- 3. Government have examined the matter in detail and are pleased to sanction the following terms and conditions of service to Dr.S.Shanavas, Technical Officer, ICAR CTCRI, Sreekaryam, Thiruvananthapuram during his deputation/ foreign service as Programme Officer in Kudumbashree State Mission.

- i. This deputation will be treated as foreign service.
- ii. The deputation will be for one year and can be extended up to three years (on year by year basis), strictly on specific request from the borrowing institution and approval by ICAR-CTCRI.
- iii. ICAR-CTCRI will hold the right to not extend the deputation beyond the period of 1 year.
- iv. ICAR-CTCRI will have the right to call back the officer any time, deputation/foreign service by giving three month notice, on account of interest.
- v. During the period of deputation/foreign service, the officer will be entitled to pay and allowances (Pay, DA, Transport Allowances, DA on transport allowance, Employer statutory NPS contribution (14%) & HRA), medical benefits as admissible in the parent institution.
- vi. Deductions/recoveries shall be made as per LPC and the same has to be remitted to the respective accounts.
- vii. The officer will be eligible for Leave salary, Children Education Allowance and Leave Travel Concession as admissible in the parent institution.
- viii. Leave salary contribution @ 11% of basic pay being drawn on deputation per month, Pension contribution @ 28% of Basic pay + DA per month will be paid by the borrowing institution and liability will be with ICAR-CTCRI on this account.
- ix. During the period of deputation, the officer will continue to be governed by the leave rules and pension rules of his parent institution.
- x. News paper allowance & Reimbursement of allowance for purchase of brief case as enjoyed in his parent department are not allowable during deputation as per clause 7.6 of OM No.6/8/2009-Estt (Pay II) dated 17.06.2010.
- xi. Out of 28% of 'pension contribution' employee contribution @10% of pay and employer contribution @14% of pay may be deposited NPS account of the employee every month under intimation to ICAR CTCRI, Sreekaryam. Remaining 4% of pay per month towards gratuity contribution may be deposited to ICAR CTCRI, Sreekaryam at the end of the period of deputation.
- xii. In case the borrowing institution fails to pay necessary contributions, the employee will be responsible to make the payment, as per rules. Failing which the period of deputation/foreign service will not be counted for any purposes, as defined by relevant rules.
